# **Special Business:**

• **Shell Terminal:** Questions were raised by the community seeking clarity as to what are and will be, the Shell emergency management plans.

It was proposed that following on from the meeting of the Emergency Management Team in early November, a presentation be made by Shell at the December GCA meeting.

Questions raised during the meeting that need to be addressed:

- 1. What is the current emergency management plan?
- 2. How are Greenwich residents to be kept informed of any proposed changes to the emergency management plan?
- 3. Public health issues pertaining to noise and smell.
- 4. Are there any potential safety issues that may arise from the change of use from oil to petrol?
- 5. Potential environment issues?
- 6. Is the refinery on the State's dangerous site list?

It was determined that suitable questions needed to be provided for the Reference Group to raise at the 14 December GCA meeting. In view of the proposed change in use at the Shell Gore Bay Terminal, it was also suggested there is a need to have an independent expert who would be able to provide a list of suitable questions that could be raised at the meeting.

In order to obtain a suitable expert in this particular field, it was agreed to set aside a budget of \$2000. *Proposed Liz Gill, seconded John May*Letter to Shell and Council regarding the 14 December meeting
Shell going ahead with the implementation of a new VCC system

Greenwich Shopping Centre Precinct Upgrade: Phase 1 has now been completed.

Phase 2 incorporating the proposed additional angle parking on the east side of Wardrop Street is being considered.

John May and Peter Walton met with Peter Brown, Council's General Manager, and Wayne Ryland re this proposal and indicated that the proposal had the support of the Greenwich Infant School.

Council indicated during the meeting that they had a number of procedures they needed to go through.

Parking Sub-committee has subsequently followed up with Council and was still waiting for a response.
