ONGOING CONCERNS FOR 2016

VIVA GORE BAY FUEL DEPOT

As reported in our last newsletter, the GCA has made a lengthy submission to the EPA (Environmental Protection Authority) regarding the review of the EPA licence for the Gore Bay Terminal operations. Our submission can be accessed on our website. We are awaiting details of variations (if any) to the licence, which the EPA has advised us to expect in early 2016.

The licence review is not the only Gore Bay item in the EPA's Inbox this year. Over the weekend of January 16 and 17 several residents from various parts of the peninsula reported to president Tom Gervay, Viva and the EPA offensive odours from the terminal. We were advised by Viva that there was an unintended consequence while unloading fuel - inert gases were released into the atmosphere.

On this note, Viva has advised that its contact number to report complaints to terminal management is 8437 1238 or refer to https://www.vivaenergy.com.au/operations/gore-bay/about-us to make comments and provide feedback to Viva Energy Australia. Viva has advised us that if callers leave their name and contact details and request a call back then their calls will be appropriately attended to.

Another point of contact is the EPA Environment Line 131 555, which will accept complaints on an anonymous basis.

Residents may have noticed the appearance of a new vessel in the bay. The *Reliance* has replaced the *Destine* to provide bunkering operations for vessels in the harbour. The EPA has advised us that "the new vessel has bow and stern thrusters, and while this negates the need for a second tug.....there are aspects of the motors and operations that seem to produce a level of noise...Viva advises that it is monitoring noise using hand held monitors and expects that the noise impacts will be reduced by using lower revs and speeds when arriving and leaving the berth."

It remains a difficult task treading the fine line between our community's interests and corporate commercial realities. The GCA strives to ensure the health, safety and well being of our community.

COUNCIL AMALGAMATIONSIS BIGGER BETTER? IT APPEARS THAT THE PEOPLE SAY 'NO'

The State Government is trying to renege on its pre-election promise that there would be no forced amalgamation of NSW Councils. They are now proposing the amalgamation of Lane Cove, Hunters Hill and Ryde Councils, against the wishes of those Councils.

At the Council Boundary Review held on 2 February 2016 the three mayors argued that amalgamation provides no cost savings and reduces the voice of individuals. They proposed that the Joint Regional Authority (JRA) which they have already established, is a far better way of achieving operational efficiencies. Surveys by each Council have found that over 80% of their residents oppose forced amalgamations. The mayors also cited recent Council amalgamations in Queensland and Victoria which increased rates and reduced community representation.

MARSHALL AVE ST LEONARDS – REVISITED

The Marshall Avenue Loftex tower is before the Joint Regional Planning Panel (JRPP) for approval again, despite it being rejected as unsuitable back in March 2015.

Council is pushing for changes in the zoning to allow the tower at the increased height, and working on extending the rezoning to Park Road, which will mean permitting resumption of houses to broaden roads to accommodate the increase in traffic.

The second was completion of the first phase in the construction of a major retaining wall along a section of the bush track from the ferry wharf to Shell Park which had been subject to dangerous subsidence.
