# SO MANY COOKS, BUT WHO IS RUNNING THE KITCHEN?

It is hard to recall a time when there have been so many plans for Sydney's development with so little clarity about who does what.

Council amalgamation is still up in the air despite the NSW government's attempt force capitulation with threats of council elections for the recalcitrants being delayed until 2018 and possibly 2020. who Councils are fighting amalgamation are keeping their options open while waiting on a Court of Appeal decision.

Meanwhile major developments in East Ward are progressing. The St Leonards South Master Plan, that will create a high pocket density residential bounded by River Road, Park Street East, Marshall Avenue and Canberra Avenue, has passed the Department Planning Gateway process. This plan will significantly alter the character of this precinct and will generate significant demands on infrastructure which must be addressed as part of the Gateway approval. It is expected that the LEP amendment to give effect to this plan will go on exhibition in early 2017. The recently formed Great Sydney Commission, responsible for "big picture planning" for Greater Sydney has released for discussion its Draft North District Plan. The plan is worth a read as its focus on St Leonards/Crows Nest as a priority precinct will undoubtedly impact Greenwich. The draft plan can be found on the GSC website:

www.greater.sydney, go to 'District Plans', then 'North', and it will be on exhibition for comment until the end of March 2017. The GCA will work on its response after Christmas/ New year.

## **VIVA AND THE EPA**

Despite the EPA's assurances in August that the renewed Viva licence would include ongoing monitoring of emissions at the facility's boundaries, the licence allows Viva to continue operating without that monitoring in place, with a very loose condition

requiring Viva to "investigate the feasibility" of monitoring.

This is unsatisfactory in our view and we will continue to seek discussions with both the Premier and NSW Minister for Health.

#### **SULFUR EMISSIONS**

We were pleased to read a SMH report about how the Turnbull government has agreed to revive restrictions on the sulfur content of fuels used by cruise ships at dock in Sydney Harbour.

The GCA and other waterside community groups have long been concerned about harmful emissions from the 90,000-plustonne vessels that berth in the harbour. The NSW Government had enforced the use of low-sulfur fuel inside the harbour but in June a federal-state jurisdictional issue rendered the NSW law inoperative and the federally mandated minimum of 3.5 percent remained.

This has now been overturned and an upper limit of 0.1 percent for fuel-oil sulfur content has been instituted. The GCA welcomes this news and we will keep pushing for it to apply to tankers as well.

### **NEW CONCERNS WE WANT TO ADDRESS** (it never stops, does it!)

You will notice on our website a list of Crown land properties in Greenwich. Crown land is a valuable community asset handed down to us residents in our Constitution, and it is ours to use to benefit the community, whether that be active as in parks and community facilities, or passive, as in maintaining green corridors and bushland.

Unfortunately, governments at all levels have cottoned onto that much of this Crown land is a valuable commodity, and as such could be sold or commercially developed to bring in revenue for government coffers. Comparing lists of Crown land parcels of today with even 10 years ago reveals just how much of Crown land has been sold off by stealth.

The recent changes to Crown land legislation reflect this disturbing trend, and we want to alert residents that this is happening here. Greenwich Baths is an important case in point. This is Crown land that has had a lot of money put into it, with current and recent upgrading, and Council may be wanting to recoup that investment. It is unfair of us to speculate; suffice to say that we are aware of the commercial advantages of properties such as this and we want to make sure it remains as a community asset.

To this end, we intend to establish a sub committee specifically for the Baths. If any residents are concerned about the future of the Baths and/or if you are interested in joining this sub committee then please come to the next meeting.
